This is a legal document granting you the right to use the beat(s) (hereinafter referred to as the "Composition(s)") chosen below (see bottom of contract). Please sign and keep for your own records. This License agreement is made by and between: **Robert Matthew Bentley (Matt Bentley GT, gtbeats.biz)** (hereinafter referred to as "Licensor") AND \_\_\_\_\_ (hereinafter referred to as "Licensee") The Licensor and Licensee have agreed to the following terms:

1.

The Licensor grants to Licensee a Exclusive License to use the Composition(s) partly or substantially in its/their original form in the recording, manufacture, and distribution of phonograph records, cassette tapes, compact disks, other and miscellaneous audio and digital recordings, and any lifts and versions thereof (collectively, the "Recordings") worldwide for the pressing or digital distribution of **UNLIMITED** copies of such Recordings or any combination of such Recordings

2.

The Composition(s) **may** be used for radio broadcasts, live shows and concerts or commercial soundtracks for movies, television, videogames and other media channels without prior consent by Licensor. The Composition(s) may be uploaded online to websites and YouTube channels and monetized.

3.

The Licensee is expressly forbidden to resale the Composition(s), either as they exist or any modifications thereof. The Licensee cannot sell, loan, rent, lease, assign, remix, rearrange or remove any melodies and tags without prior written consent from Licensor.

4.

Licensee shall acknowledge the original authorship of the Composition(s) appropriately and reasonably in all media and performance formats by acknowledging the relevant author in writing where possible and vocally otherwise (for example: **Produced by Matt Bentley GT - gtbeats.biz**). Where a project is commercially released and registered with a performance rights organisation, **Matt Bentley GT** or **Robert Matthew Bentley** shall be acknowledged as a Writer. (registered BMI)

5.

Licensee agrees to indemnify and hold Licensor harmless from and against any and all claims, losses, damages, costs, and expenses, including, without limitation, reasonable attorneys' fees, arising out of or resulting from a claimed breach of any of Licensee's representations, warranties or agreements hereunder.

6.

The Licensee agrees that the Composition(s) is/are purchased as a "Work Made for Hire" whereby the clearing of any sampled materials is the responsibility of Licensee.

7.

This License is non-transferable and is limited to the Composition(s) specified below, constitutes the entire agreement between the Licensor and the Licensee relating to the Composition(s), and shall be binding upon both the Licensor and the Licensee and their respective successors, assigns, and legal representatives.

8.

This License is governed by and shall be construed under the laws of the United States of America, without regard to the conflicts of laws and principles thereof.

9.

The Licensor agrees to cease future sale / leasing of the Composition(s) to any other parties.

10.

The Licensee agrees to sign and return this License Agreement within Thirty (30) days of purchase. Failure to comply with this condition will render this agreement NULL and VOID. The Licensee agrees that any payment made to the Licensor will be non-refundable.
